

Terms and Conditions

Rosenberger IMS 2023 Drone Giveaway

1. Eligibility

The Rosenberger IMS 2023 Drone Giveaway (the "Giveaway") is open to legal residents of the United States who are at least 18 years of age at the time of entry.
